BILL REQUESTS AND GENERAL SESSION DEADLINE FOR:

<i>November 29, 2022 (Tuesday)</i>	Members to request bills. Members may not introduce more than five bills. Of the five bills, excluding appropriations and interim bills, not more than two bills may be requested after November 29.	Pre-session
<i>December 13, 2022 (Tuesday)</i>	Deadline for newly elected members to request three of five bills.	Pre-session
<i>January 4 (Wednesday)</i>	Filing one of each member's three bills requested prior to November 29 or December 13 with the house of introduction for printing, distribution to Legislative Council Staff for preparation of fiscal notes, and introduction on the 1st day.	Pre-session
<i>January 9 (Monday)</i> General Assembly Convenes	Introducing bills required to be filed 5 days prior to the 1st day and bills to increase the number of judges .	1st Day
<i>January 11 (Wednesday)</i>	Introducing the two remaining Senate bills requested prior to November 29 or December 13.	3rd Day
<i>January 13 (Friday)</i>	Submitting remaining bill requests to the Office of Legislative Legal Services.	5th Day
<i>January 17 (Tuesday)</i>	Introducing the two remaining House bills requested prior to November 29 or December 13.	9th Day
<i>January 25 (Wednesday)</i>	Introducing Senate bills , except for supplemental appropriation bills recommended by the Joint Budget Committee and the Long Bill.	17th Day
<i>January 30 (Monday)</i>	Introducing House bills .	22nd Day
<i>February 6 (Monday)</i>	Introducing supplemental appropriation bills recommended by the Joint Budget Committee.	29th Day
<i>March 1 (Wednesday)</i>	Final passage of Senate bills in the Senate and House bills in the House.*	52nd Day
<i>March 8 (Wednesday)</i>	Final passage of any bill that increases the number of judges .	59th Day
<i>March 27 (Monday)</i>	Introducing the Long Bill in the Senate.	78th Day
<i>March 31 (Friday)</i>	Final passage of the Long Bill in the Senate.	82nd Day

<i>January 22 (Sunday)</i>	Joint committees to meet with state departments to review performance plans, regulatory agendas, and budget requests.	14th Day
<i>February 7 (Tuesday)</i>	House committees to report House bills introduced on or before the 9th legislative day, other than the House Appropriations Committee.	30th Day
<i>February 14 (Tuesday)</i>	Senate committees to report Senate bills, other than the Senate Appropriations Committee.	37th Day
<i>February 21 (Tuesday)</i>	House committees to report remaining House bills, other than the House Appropriations Committee.	44th Day
<i>March 22 (Wednesday)</i>	Committees to report bills originating in the other house, other than the Appropriations Committees and Legislative Council.	73rd Day
<i>April 5 (Wednesday)</i>	Committees in the house of introduction, including the Appropriations Committee, to report bills creating statutory committees with legislative members.	87th Day
<i>April 14 (Friday)</i>	Appropriations Committee in house of introduction to report referred bills.	96th Day
<i>April 19 (Wednesday)</i>	Committees in the second house to report bills creating statutory committees with legislative members to the Legislative Council.	101st Day
<i>April 25 (Tuesday)</i>	Committees in the second house to report bills referred to the Appropriations Committee in that house.	107th Day

INTERIM STUDIES, DEADLINE FOR:

<i>April 12 (Wednesday)</i>	Submitting written requests to the Legislative Council for interim studies.	94th Day
<i>April 18 (Tuesday)</i>	Legislative Council Director of Research to submit to the Legislative Council Executive Committee the number of interim committee meetings that may be held.	100th Day
<i>April 26 (Wednesday)</i>	Legislative Council to meet to review and prioritize requests from legislative members for interim studies.	108th Day

* All bills in the Appropriations Committee in either house on the day of the asterisked final passage deadline are excluded from the final passage deadline and from other deadlines specified in this Joint Rule until the deadlines for passing bills in the Appropriations Committee or passing bills or resolutions in the Legislative Council.
