## BILL REQUESTS AND GENERAL SESSION DEADLINE FOR:

December 1, 2023 (Friday)	Members to request bills. Members may not introduce more than five bills. Of the five bills, excluding appropriations and interim bills, not more than two bills may be requested after December 1.	Pre-session
January 5 (Friday)	Filing one of each member's three bills requested prior to December 1 with the house of introduction for printing, distribution to Legislative Council Staff for preparation of fiscal notes, and introduction on the 1st day.	Pre-session
January 10 (Wednesday) <b>General Assembly Convenes</b>	Introducing bills required to be filed 5 days prior to the 1st day and bills to increase the <b>number of judges</b> .	1st Day
January 16 (Tuesday)	Deadline for all remaining bill draft requests to the Office of Legislative Legal Services.	7th Day
January 19 (Friday)	Introducing the two remaining <b>Senate bills</b> requested prior to December 1.	10th Day
January 26 (Friday)	Introducing the two remaining <b>House bills</b> requested prior to December 1.	17th Day
February 2 (Friday)	Introducing <b>Senate bills</b> , except for supplemental appropriation bills recommended by the Joint Budget Committee and the Long Bill.	24th Day
February 5 (Monday)	Introducing <b>supplemental appropriation bills</b> recommended by the Joint Budget Committee.	27th Day
February 9 (Friday)	Introducing <b>House bills</b> , except for supplemental appropriation bills recommended by the Joint Budget Committee and the Long Bill.	31st Day
March 8 (Friday)	Final passage of any bill that increases the <b>number of judges</b> .	59th Day
March 15 (Friday)	Final passage of <b>Senate bills</b> in the Senate and <b>House bills</b> in the House.*	66th Day
March 25 (Monday)	Introducing the <b>Long Bill</b> in the House.	76th Day
March 29 (Friday)	Final passage of the <b>Long Bill</b> in the House.	80th Day
April 5 (Friday)	Final passage of the <b>Long Bill</b> in the Senate.	87th Day

April 8 (Monday)	Introducing resolutions and memorials.	90th Day
April 12 (Friday)	Adoption of the conference committee report on the <b>Long Bill</b> .	94th Day
April 18 (Thursday)	Introducing bills.	100th Day
April 19 (Friday)	Final passage, including any conference committee report, for any school finance bills.	101st Day
April 23 (Tuesday)	Final passage of <b>House bills</b> in the Senate and <b>Senate bills</b> in the House.*	105th Day
May 1 (Wednesday)	Final passage in house of introduction of all bills referred to Appropriations Committee in that house.	113th Day
May 6 (Monday)	Reconvene for adjournment sine die if there has been adjournment to a day certain, unless the joint resolution for adjournment to a day certain specifies another day for reconvening.	118th Day
May 8 (Wednesday)	Final passage in second house of all bills referred to Appropriations Committee in that house.	120th Day

<i>January 23 (Tuesday)</i>	Joint committees to meet with state departments to review performance plans, regulatory agendas, and budget requests.	14th Day
<i>February 23 (Friday)</i>	House committees to report House bills introduced on or before the 17th legislative day, other than the House Appropriations Committee.	45th Day
<i>March 1 (Friday)</i>	Senate committees to report Senate bills, other than the Senate Appropriations Committee.	52nd Day
<i>March 8 (Friday)</i>	House committees to report remaining House bills, other than the House Appropriations Committee.	59th Day
<i>April 12 (Friday)</i>	Committees to report bills originating in the other house, other than the Appropriations Committees and Legislative Council.	94th Day
<i>April 26 (Friday)</i>	Appropriations Committee in house of introduction to report referred bills.  Legislative Council to report bills.	108th Day
<i>May 3 (Friday)</i>	Committees in the second house to report bills referred to the Appropriations Committee in that house.	115th Day
<i>May 6 (Monday)</i>	Appropriations Committee in second house to report bills.	118th Day

## **INTERIM STUDIES, DEADLINE FOR:**

<i>April 12 (Friday)</i>	Submitting written requests to the Legislative Council for interim studies.	94th Day
<i>April 18 (Thursday)</i>	Legislative Council Director of Research to submit to the Legislative Council Executive Committee the number of interim committee meetings that may be held.	100th Day
<i>April 26 (Friday)</i>	Legislative Council to meet to review and prioritize requests from legislative members for interim studies.	108th Day
